4. Presentation – Harder + Company– Kindergarten Bridge Initiative Newsletter

Kristi Koumjian, Director with Harder + Co, presented the Kindergarten Bridge Initiative Evaluation Highlights from 2016-2017. She discussed the background of the bridge program which was held at 35 school sites, with teachers and parents with children in program participating in the survey. Nancy Leal, Manteca Unified School District Director of School Readiness, thanked First 5 for the support of the bridge program and reported that every elementary school in the district has a bridge program in place. She introduced Lisa Hern, Principal of Sequoia Elementary, who spoke about her school and how the program helps teachers build relationships with parents and children. Commission discussion followed the presentation.

5. Executive Director's Report

Lani Schiff Ross, Executive Director (ED), presented Commissioner Miller with a High 5 award for appreciation of his service as Commission Chair. ED thanked the agencies for working on various documents and getting them to First 5 staff in a timely manner during this contract renewal season. She reminded agencies that the contracts over \$250k will be going to the Board of Supervisors on June 12, 2018. She discussed the different funding sources for the upcoming year. ED recognized Commissioner Dei Rossi for his induction into the Hall of Fame for Education.
